TERMS & CONDITIONS FOR THE SUPPLY OF ELECTRICAL ENERGY & FITTINGS ON HIRE

- 1. Supply 230 volts single phase, 400 volts three phase 50 cycles Alternating Current (AC).
- 2. The charges detailed on the price list include for the supply ON HIRE and installation from the electricity power supply, a proportion of the necessary mains cable, overhead/underground network, switch fuse and control gear, together with all necessary circuit wiring and fittings and for taking down and removing at the close of show.
- 3. The electricity supply will be terminated at the nearest point on the stand to the distribution pillar. Exhibitors requiring a different termination point should give details on a separate paper and attach it to the application.
- 4. It is strictly understood that ONE item of equipment only is connected to each point and the wattage of that equipment is equal to the wattage size of the socket ordered. The use of bayonet adaptors is prohibited.
- 5. Exhibitors using pre-wired or mobile stands, including caravans, must take into account the full load of its appliances. On no account must the connected load exceed the size of the supply requested. All mobile units must arrive on site fitted with a 30ma RCD trip switch and carry a current electrical test certificate.
- 6. Any exhibitor making connections themselves to the network or multiple connections from one stand to another stand holder will be immediately cut off from the original supply point and service denied to them.
- All exhibitors will be held responsible for any materials etc which are damaged or missing at the end of the show and it is the responsibility of the exhibitor to ensure that equipment is returned in good order.
- 8. Applications for the supply must be received by us no later than the date stated on the order form, after which date no guarantee will be given that the work will be carried out, or until after the completion of all orders received prior to this date, but if it is carried out the cost will be as price list plus the surcharge for modifications to our supply network.
- 9. Positions of points on your stand will be at a mutually agreed practical position. Alterations may result in further charges.
- 10. Complaints with regard to the services provided <u>must be</u> submitted in writing during the open period of the event. This will ensure that they are fully investigated on site. No liability for claims can be accepted unless this condition is complied with.
- 11. We reserve the right to refuse to connect to the supply of any faulty equipment. Any work carried out on equipment to bring it to the required standard will be charged on a time and material basis and an estimate of the cost to be payable in advance.
- 12. The use of personal generating sets is strictly prohibited other than for the purpose of demonstration.
- 13. We shall not be held responsible for the loss of power due to faulty appliances tripping the main R.C.D device.
- 14. Supply of electricity should normally be available to most stands from midday on the day prior to the show commencing until the official closure of the show. However, should this not be possible for whatever reason AAC Power Solutions Ltd cannot be held responsible and will NOT accept any claims for loss of earnings or otherwise.
- 15. Refunds for cancellations will only be given if notice of cancellation is received by AAC Power Solutions Ltd, in writing, prior to the deadline date stated on the order form. Where written cancellation is received later than this date the services ordered will be charged at the full rate as the work is prepared in advance.
- 16. Any portable electrical appliance over 12 months old, intended for use at this event must display PATS tested certificate, otherwise power will not be connected.
- 17. We reserve the right to disconnect and remove to the organiser's office any appliance which is faulty and without a current P.A.T certificate.
- 18. No work will be carried out unless payment is submitted with the order form.
- 19. All cheques should be made payable to AAC Power Solutions Ltd.

Conditions of Contract

- 1. Connections to the mains will be made when all conditions of the electrical schedule are fulfilled.
- 2. In the event of fire, flood, earthquake, windstorm or other natural disaster, labour difficulties, acts or omissions of sub-contractors or any other cause beyond the control of AAC Power Solutions Ltd which render AAC Power Solutions Ltd unable to provide all or any of the services ordered by the customer during the event AAC Power Solutions Ltd will be released from their obligations under the contract and the customer will be entitled to a return of the monies paid by him less an amount which will be retained for the reasonable costs incurred by AAC Power Solutions Ltd.
- 3. AAC Power Solutions Ltd, its employees or agents of their employees will be not be liable for damage to property or death or injury to persons by or in any way connected with the services to be provided, except only where such damage or death or injury is occasioned by the negligence of AAC Power Solutions Ltd, its employees or its agent or their employees.
- 4. On no account will AAC Power Solutions Ltd be liable for any direct or indirect consequential loss suffered by the customer howsoever caused.
